

The Croc Festivals are part of a proactive approach taken by health departments to tackle the drug and alcohol education issues that concern rural and remote communities in Australia.



The Festivals are also a demonstration of a successful partnership between schools, communities, organisers (Indigenous Festivals of Australia), Commonwealth and State governments, and community organisations.
