<b>Descriptor</b>	This unit of competency describes the skills and knowledge required to provide first aid response, life support, management of casualty(s), the incident and other first aiders, until the arrival of medical or other assistance.
<b>Pre- /co-requisites</b>	There are no pre-requisites or co-requisites for this competency unit. This unit incorporates the content of units: <ul style="list-style-type: none"> <li>• HLTCPR201A Perform CPR</li> <li>• HLTFA201A Provide basic emergency life support.</li> </ul>
<b>Application</b>	These skills and knowledge may be applied in a range of situations, including community and workplace settings. Training Package users should ensure implementation is consistent with any specific workplace and/or relevant legislative requirements in relation to first aid, including State/Territory requirements for currency. Application of these skills and knowledge should be contextualised as required to address specific industry, enterprise or workplace requirements and to address specific risks and hazards and associated injuries. A current Senior First Aid, Workplace Level 2 or Level 2 qualification may provide evidence of skills and knowledge required by this competency unit. However, as with all evidence of competence, evidence must be assessed against the requirements specified in the competency unit.

## Required Skills and Knowledge

This describes the essential skills and knowledge and their level required for this unit.

### *Essential knowledge:*

- ARC Guidelines relating to provision of first aid as outlined
- working knowledge of:
  - basic principles and concepts underlying the practice of first aid
  - procedures for dealing with major and minor injury and illness
  - priorities of management in first aid when dealing with life threatening conditions
  - basic occupational health and safety requirements in the provision of first aid
  - infection control principles and procedures, including use of standard precautions
  - chain of survival
  - first aiders' skills and limitations
- understanding of the use of an Automated External Defibrillator (AED), including when to use and when not to
- first aid management of:
  - abdominal injuries
  - allergic reactions
  - altered and loss of consciousness
  - bleeding
  - burns – thermal, chemical, friction, electrical
  - cardiac arrest
  - casualty with no signs of life
  - chest pain
  - choking / airway obstruction
  - injuries: cold and crush injuries; eye and ear injuries; head, neck and spinal injuries; minor skin injuries; needle stick injuries; soft tissue injuries including sprains, strains, dislocations
  - envenomation – snake, spider, insect and marine bites
  - environmental impact such as hypothermia, hyperthermia, dehydration, heat stroke
  - fractures
  - medical conditions, including cardiac conditions, epilepsy, diabetes, asthma and other respiratory conditions
  - near drowning
  - poisoning and toxic substances (including chemical contamination)
  - respiratory distress
  - seizures
  - shock
  - stroke
  - substance misuse – common drugs and alcohol, including illicit drugs
- awareness of stress management techniques and available support
- social/legal issues:
  - duty of care
  - need to be culturally aware, sensitive and respectful
  - importance of debriefing
  - confidentiality
  - own skills and limitations.

### *Essential skills:*

#### Ability to:

- conduct an initial casualty assessment
- plan an appropriate first aid response in line with established first aid principles, policies and procedures, ARC Guidelines and/or State/Territory regulations, legislation and policies and industry requirements and respond appropriately to contingencies in line with own skills
- demonstrate correct procedures for performing CPR using a manikin, including standard precautions
- apply first aid principles
- infection control, including use of standard precautions
- follow OH&S guidelines
- demonstrate:
  - safe manual handling
  - consideration of the welfare of the casualty
  - ability to call an ambulance
  - site management to prevent further injury
- provide assistance with self-medication as per subject's own medication regime and in line with State/Territory legislation, regulations and policies and any available medical/pharmaceutical instructions
- administer medication in line with State/Territory regulations, legislation and policies
- prepare a written incident report or provide information to enable preparation of an incident report
- communicate effectively and assertively in an incident
- make prompt and appropriate decisions relating to managing an incident in the workplace
- call an ambulance and/or medical assistance according to relevant circumstances and report casualty's condition
- use literacy and numeracy skills as required to read, interpret and apply guidelines and protocols
- evaluate own response and identify appropriate improvements where required.

1 Assess the situation	1.1 Identify assess and minimise <b>hazards</b> in the situation that may pose a risk of injury or illness to self and others.	<p>The Range Statement relates to the unit of competency as a whole. It allows for different work environments and situations that may affect performance. Add any essential operating conditions that may be present with training and assessment depending on the work situation, needs of the candidate, accessibility of the item, and local industry and regional contexts.</p> <p><b>Contextualisation to address specific requirements</b> may include:</p> <ul style="list-style-type: none"> <li>• focus on first aid management of specific types of injury</li> <li>• first aid provision under specific constraints or circumstances (eg. in confined spaces, in maritime work environment or in work environment involving identified risks/hazards).</li> </ul> <p>A <b>hazard</b> is:</p> <ul style="list-style-type: none"> <li>• a source or situation with the potential for harm in terms of human injury or ill-health, damage to property, the environment, or a combination of these.</li> </ul> <p><b>Hazards</b> may include:</p> <ul style="list-style-type: none"> <li>• physical hazards</li> <li>• biological hazards</li> <li>• chemical hazards</li> <li>• hazards associated with manual handling.</li> </ul>
	1.2 Minimise immediate <b>risk</b> to self and casualty's health and safety by controlling any hazard in accordance with occupational health and safety requirements.	<p><b>Risks</b> may include:</p> <ul style="list-style-type: none"> <li>• risks from equipment, machinery and substances</li> <li>• risks from first aid equipment</li> <li>• environmental risks</li> <li>• exposure to blood and other body substances</li> <li>• risk of further injury to the casualty</li> <li>• risks associated with the proximity of other workers and bystanders</li> <li>• risks from vehicles.</li> </ul>
	1.3 Assess casualty and identify injuries, illnesses and conditions.	<p><b>Vital signs</b> include:</p> <ul style="list-style-type: none"> <li>• consciousness</li> <li>• breathing</li> <li>• circulation.</li> </ul>
2 Apply first aid procedures	2.1 Calmly provide information to reassure casualty, adopting a communication style to match the casualty's level of consciousness.

	2.2 Use available <i>resources and equipment</i> to make the casualty as comfortable as possible.	<p><i>Resources and equipment</i> are used appropriate to the risk to be met and may include:</p> <ul style="list-style-type: none"> <li>• AED</li> <li>• first aid kit</li> <li>• auto-injector</li> <li>• puffer/inhaler</li> <li>• resuscitation mask or barrier</li> <li>• spacer device.</li> </ul>
	2.3 Respond to the casualty in a culturally aware, sensitive and respectful manner.	
	2.4 Determine and explain the nature of casualty's injury/condition and relevant first aid procedures to provide comfort.	
	2.5 Seek consent from casualty prior to applying first aid management.	
	2.6 Provide <i>first aid management</i> in accordance with <i>established first aid principles</i> and Australian Resuscitation Council (ARC) Guidelines and/or State/Territory regulations, legislation and policies and industry requirements.	<p><i>First aid management</i> <u>must</u> take into account applicable aspects of:</p> <ul style="list-style-type: none"> <li>• the setting in which first aid is provided, including: <ul style="list-style-type: none"> <li>- workplace policies and procedures</li> <li>- industry/site specific regulations, codes etc.</li> <li>- OHS requirements</li> <li>- state and territory workplace health and safety legislative requirements</li> <li>- location and nature of the incident</li> <li>- situational risks associated with, for example, electrical and biological hazards, weather, motor vehicle accidents</li> <li>- location of emergency services personnel.</li> </ul> </li> <li>• the use and availability of first aid equipment and resources</li> <li>• infection control</li> <li>• legal and social responsibilities of first aider.</li> </ul> <p><i>Established first aid principles</i> <u>include</u>:</p> <ul style="list-style-type: none"> <li>• preserve life</li> <li>• prevent illness, injury and condition(s) becoming worse</li> <li>• promote recovery</li> <li>• protect the unconscious casualty.</li> </ul>

	2.10 Monitor <i>casualty's condition</i> and respond in accordance with effective first aid principles and procedures.	<p><b><i>Casualty's condition is managed for:</i></b></p> <ul style="list-style-type: none"> <li>• abdominal injuries</li> <li>• airway obstruction</li> <li>• allergic reactions</li> <li>• altered and loss of consciousness</li> <li>• bleeding</li> <li>• burns – thermal, chemical, friction, electrical</li> <li>• chest pain/cardiac arrest</li> <li>• injuries: cold and crush injuries; eye and ear injuries; head, neck and spinal injuries; minor skin injuries; needle stick injuries; soft tissue injuries including sprains, strains, dislocations</li> <li>• near drowning</li> <li>• envenomation – snake, spider, insect and marine bites</li> <li>• environmental conditions such as hypothermia, hyperthermia, dehydration, heat stroke</li> <li>• fractures</li> <li>• medical conditions, including cardiac conditions, epilepsy, diabetes, asthma and other respiratory conditions</li> <li>• no signs of life</li> <li>• poisoning and toxic substances (including chemical contamination)</li> <li>• respiratory distress/arrest</li> <li>• seizures</li> <li>• shock</li> <li>• stroke</li> <li>• substance misuse – common drugs and alcohol, including illicit drugs.</li> </ul>

3 Communicate details of the incident.	3.1 Request ambulance support and/or appropriate medical assistance according to relevant circumstances using relevant <b><i>communication media and equipment</i></b> .	<p><b><i>Communication media and equipment</i></b> may include but are not limited to:</p> <ul style="list-style-type: none"> <li>• telephones, including landline, mobile and satellite phones</li> <li>• HF/VHF radio</li> <li>• flags</li> </ul>

	3.2 Accurately convey assessment of casualty's condition and management activities to ambulance services /other emergency services/relieving personnel.	
	3.3 Prepare reports as appropriate in a timely manner, presenting all relevant facts according to established procedures.	<p><b>Documentation</b> may include:</p> <ul style="list-style-type: none"> <li>• injury report forms</li> <li>• workplace documents as per organisation requirements.</li> </ul> <p>Documentation may include <b>recording</b>:</p> <ul style="list-style-type: none"> <li>• time</li> <li>• location</li> <li>• description of injury</li> <li>• first aid management</li> <li>• fluid intake/output, including fluid loss via: <ul style="list-style-type: none"> <li>- blood</li> <li>- vomit</li> <li>- faeces</li> <li>- urine</li> </ul> </li> <li>• administration of medication including: <ul style="list-style-type: none"> <li>- time</li> <li>- date</li> <li>- person administering</li> <li>- dose</li> </ul> </li> <li>• vital signs.</li> </ul>
	3.4 Accurately record details of casualty's physical condition, changes in conditions, management and response to management in line with established procedures.	
	3.5 Maintain confidentiality of records and information in line with privacy principles and statutory and/or organisation policies.	
4 Evaluate own performance.	4.1 Seek feedback from <i>appropriate clinical expert</i> .	<p><b>Appropriate clinical expert</b> may include:</p> <ul style="list-style-type: none"> <li>• supervisor/manager</li> <li>• ambulance officer/paramedic</li> <li>• other medical/health worker.</li> </ul>
