Demonstrates a well-developed ability to comprehend both global meaning and detail, evaluate and respond selectively by processing and synthesising information from texts. Compares and contrasts texts competently, justifying observations and opinions. Argues effectively and substantiates a point of view with appropriate textual reference and well-sequenced ideas. Demonstrates the ability to use language coherently, to convey ideas effectively, with some degree of originality and creativity, employing register and discourse forms appropriate to the audience, purpose and context. Gives a detailed analysis of text, including thematic. linguistic and stylistic features. Demonstrates thorough knowledge, understanding and appreciation of literary texts. Demonstrates a high level of understanding of contemporary issues, supported by evidence of wide reading/viewing/listening Demonstrates a sound global understanding of text and identifies some relevant detail. Demonstrates the ability to organise and express most ideas clearly with a number of weaknesses in sequencing and/or linking. Uses a broad range of vocabulary, structures and syntax with sound control of the conventions of discourse forms. Interprets some of the key features of literary texts, with little observation. Demonstrates some detail in their understanding and knowledge of the text with some weaknesses in interpretation and evaluation. Demonstrates some understanding of the literary texts with satisfactory elaboration. Displays a general knowledge of contemporary issues and provides reasonable evidence of wide reading/viewing/listening. Demonstrates elementary global understanding and identifies some appropriate detail. Demonstrates an understanding and knowledge of the text and attempts to engage with the text and offer personal observations, often with minimal justification and elaboration. Makes some attempt to organise and sequence ideas. Uses a predictable range of vocabulary, structures and syntax with some adherence to conventions of discourse forms. Displays basic knowledge of contemporary issues and demonstrates some evidence of wider reading/viewing/listening (engagement with various text types). Identifies isolated minor detail which is not necessarily relevant. Identifies some relevant factual information with little exposition, elaboration, analysis or justification. Demonstrates a limited ability to organise content in responding to text. Uses only simple vocabulary, structures and syntax, with a limited knowledge of discourse Band 2 forms. Demonstrates only a superficial understanding of literary texts. Displays minimal knowledge of contemporary issues. A mark in this band indicates that the student has achieved below the minimum standard expected. The candidature of this course was 8.
